Summary of Duties

Area of selection/Eligibility

This position is open to General Public, including locally engaged staff who are currently employed at the High Commission, who meet all of the essential requirements stated below, and whose applications are received by the closing date.

Essential Qualifications

Candidates will initially be screened against the Essential Qualifications relating to education, experience and language. **Candidates must clearly demonstrate in their cover letter and CV how they meet each of these essential qualifications.**

Education:

Master's degree from a recognized university with a major in a discipline related to the position such as Business Administration, International Trade, Commerce or Economics.

Language:

- Proficiency in English and Sinhala (reading, writing, and speaking)
- Working knowledge of Tamil

Experience:

Minimum 5 years (within past 7 years) of relevant experience in International business development, working with commercial, financial or government clients in international trade and/or investment promotion;

In addition to the above, the candidates need to demonstrate experience in any one of the following:

- a) Experience in developing relationships with clients and stakeholders, including preparing for and conducting meetings with internal and external contacts;
- b) Experience in planning programs with minimal supervision for at least one of the following: clients and partners, high-profile visits, trade shows, roundtable networking events, trade delegations;
- c) The use of modern technology and social media platforms for business development and trade promotion.

- Knowledge of Canada's trade and investment promotion policies and programs;

Abilities:

- Ability to work independently with limited supervision, as well as set and achieve specific targets.
- Ability to plan and organize programs for high level visits, business delegations, events, seminars, workshops, B2B meetings with minimal supervision;
- Ability to independently research, analyze and synthesize information, in order to provide strategic advice, briefings and written reports to management and/or clients on business opportunities and international business issues;
- Ability to provide advice to clients on business opportunities & market entry strategies that consider industry regulation and sector specific knowledge;
- Ability to respond flexibly and imaginatively to challenges.
- Ability to coordinate conflicting priorities within tight deadlines and meet work targets.
- Ability to establish effective interpersonal relationships within a team, with clients and external partners.

- Candidates **must be present in Sri Lanka** at the time of tests and interviews and will not be facilitated on our behalf by our Missions abroad.
- Candidates are entitled to participate in the appointment process in the official language of their choice. They are asked to indicate their preferred official language in their application (English or French).
- Communication for this process will be sent via email. It is the responsibility of the candidate to ensure accurate contact information is provided and updated as required.
- Please note that some email systems may block emails from unknown users. Candidates should include an email address that accepts email from unknown users and regularly check their email, including junk mail.
- Candidates selected at the screening stage will be invited for further assessment. Methods of assessment may include, but are not limited to, a written examination, an oral interview, role-play, practical tests, presentations and/or psychometric assessment.
- **Majority of testing may be done on-line and candidates are expected to have un-interrupted internet facility using MS teams and be able to be seen and heard throughout the on-line testing process.**
- Reference checks will be sought for candidates that reach interview stage and may form part of the selection process.
